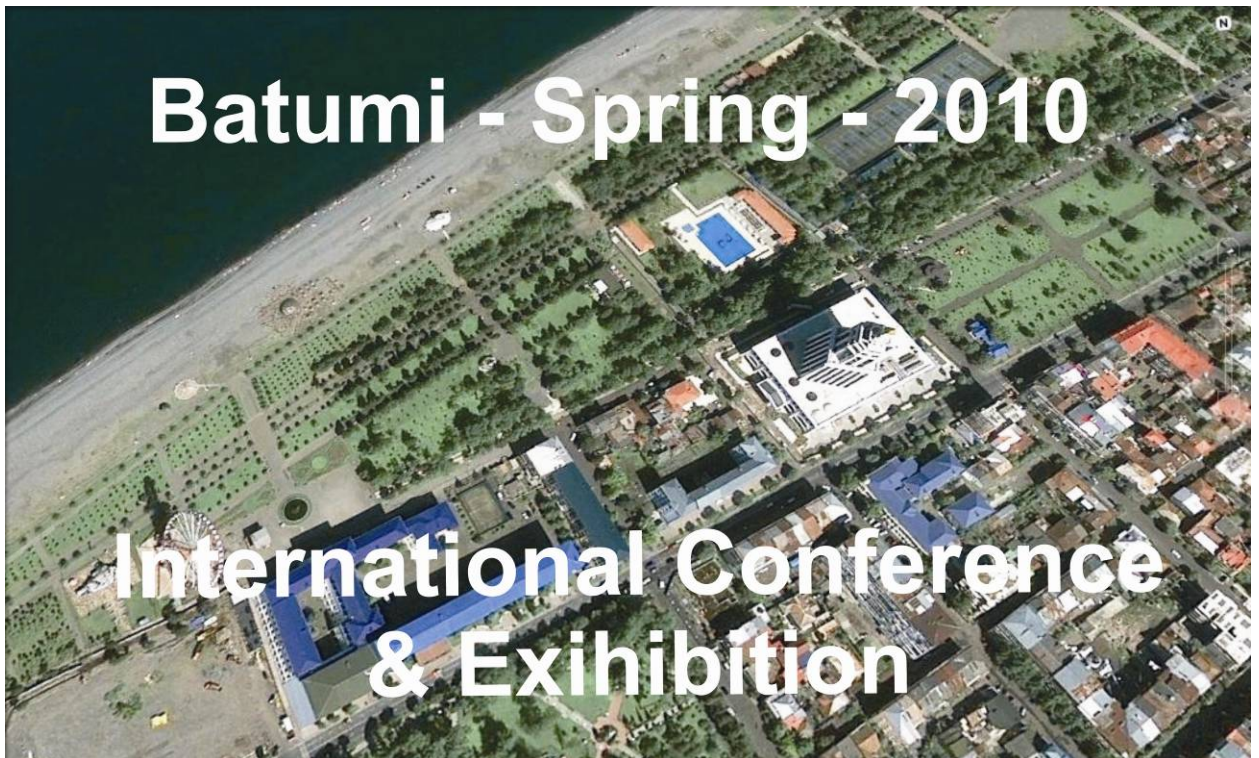

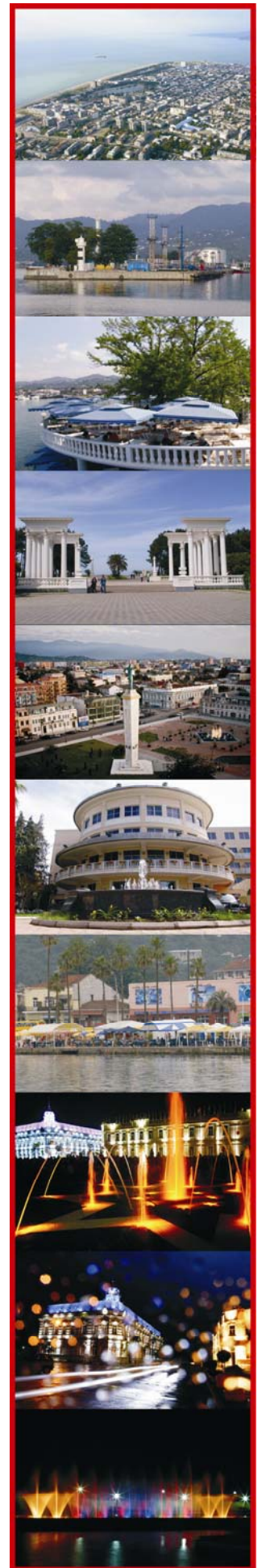
- 1. Directly to Batumi International Airport from Istanbul – all guests will be greeted by representatives of the Organizing Committee**
